## Section 4 First Aid Measures

### > Description of First Aid Measures

<b>General Advice</b>	Immediate medical attention is required. Show this safety data sheet (SDS) to the doctor in attendance.

## Section 5 Fire Fighting Measures

### > Extinguishing Media

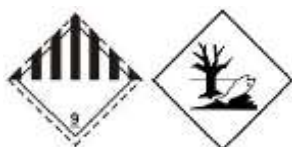
